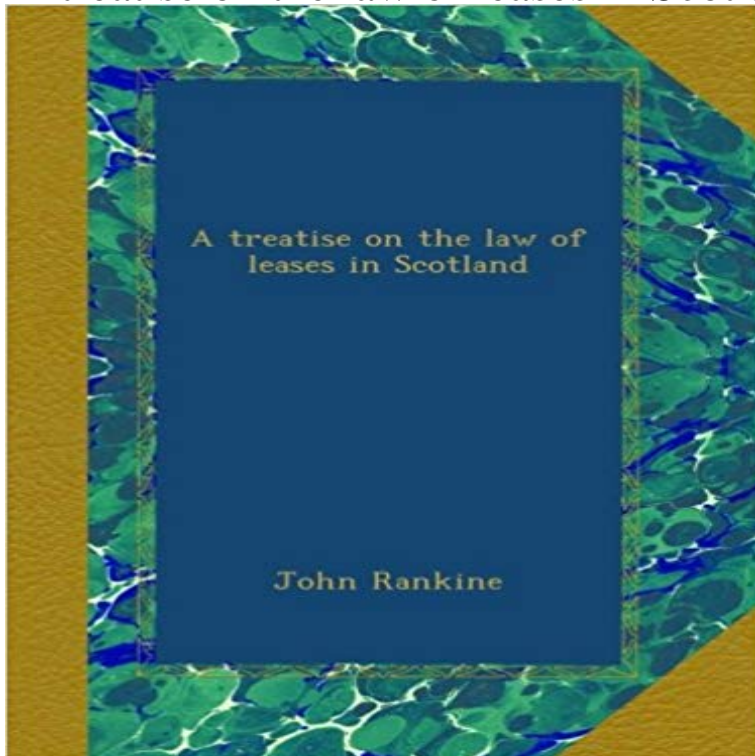


A treatise on the law of leases in Scotland
