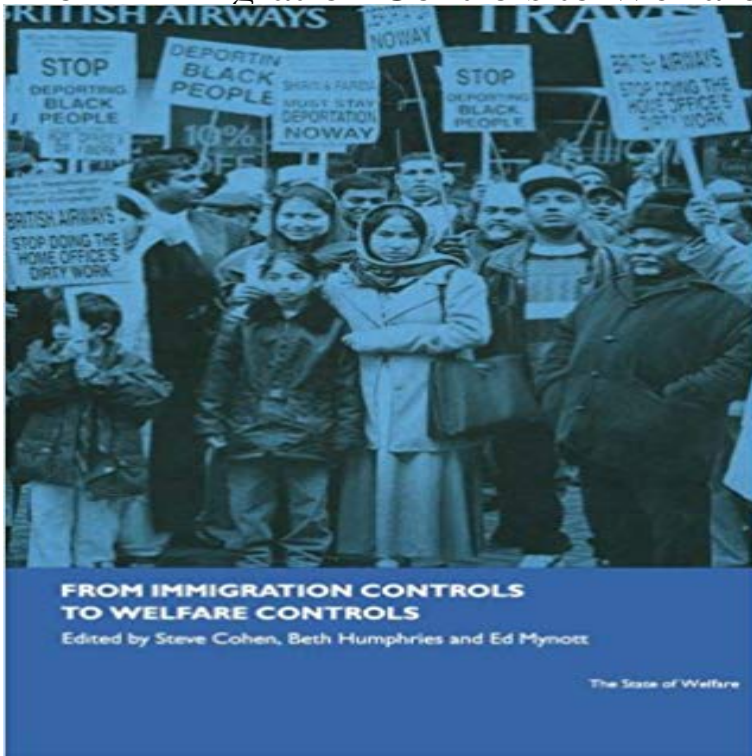


From Immigration Controls to Welfare Controls (State of Welfare)
