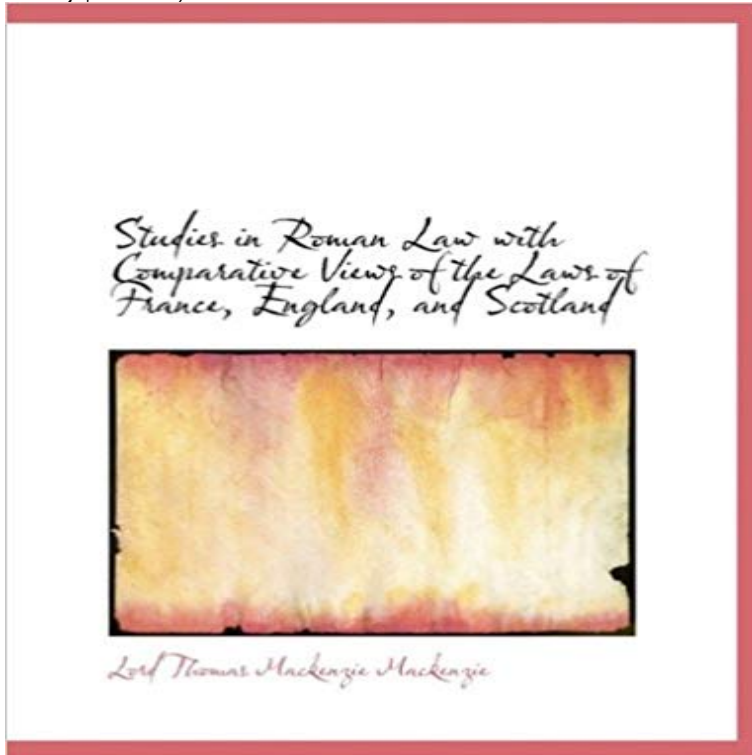


# Studies in Roman Law with Comparative Views of the Laws of France, England, and Scotland
