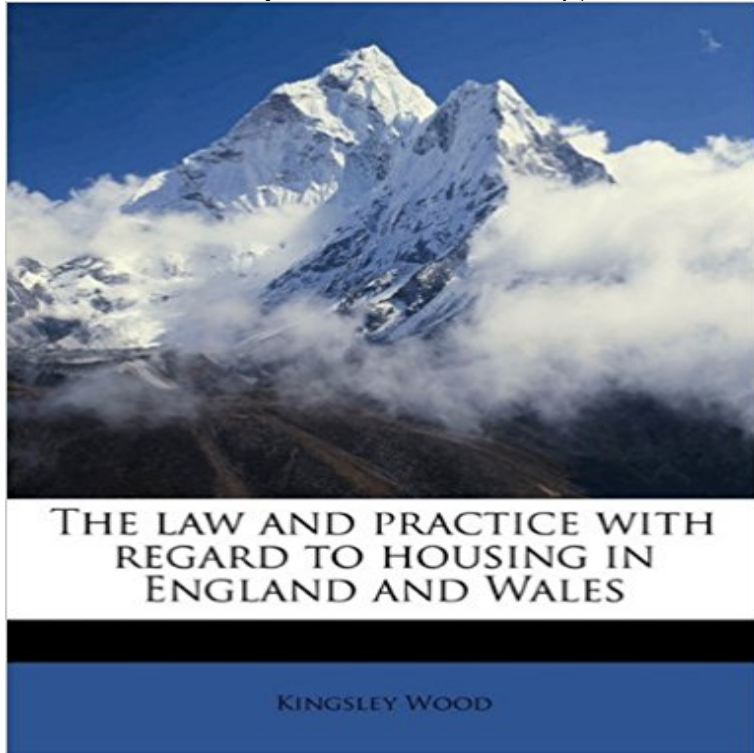


# The law and practice with regard to housing in England and Wales
